**NO. GG/110/PST/102010/848/V:** In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat hereby,-

(1) amends the Government Notification, Home Department No. GG/87/PST/102010/848/V, dated the 15<sup>th</sup> December, 2010, as under, namely:-

In the said notification, in the Schedule,-

**(i)** in the entry at serial No. 11 relating to "Dholka Sub-Division" specified in column 2 under the heading "Division/Sub-Division", in the entry relating to "Dhandhuka" specified in column 4 under the heading "Police Station", the following entries relating to "Villages" shall be added under the heading "Local Areas/ Villages", specified in column 7, namely:-

- (35) Sangasar";

(iii) in the entry at serial No. 14A relating to "Dholka Sub-Division" specified in column 2 under the heading "Division/Sub-Division", in the entry relating to "Dholera" specified in column 4 under the heading "Police Station", in the entry relating to "Fedara" specified in column 6 under the heading "Out-Post", the following entries relating to "villages" specified in column 7 under the heading "Local Areas/ Villages" shall be deleted, namely:-

"(1) Fedara,  
(3) Pachcham and  
(5) Fatepur";

(2) amends the Government Notification, Home Department No. GG/18/PST/102013/676/V, dated the 23<sup>rd</sup> January, 2014, as under, namely:-

In the said notification, in the Schedule,-

(i) in the entry at serial No. 2 relating to "Botad" specified in column 2 under the heading "Division/Sub-Division", in the entry relating to "Paliyad" specified in column 4 under the heading "Police Station", the entry relating to "Ratanpur" village specified in column 7 under the heading "Local Areas/ Villages" shall be deleted;
