No. GG /17/TTC/10(2002)/1310/V:- In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat hereby amends the Government Notification, Home Department No. GG/94/TTC/10(2002)/1310/V dated the 11th November, 2005 as under:-
