No.GG/3-14C/10201/282/Part-I/V.—In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat hereby amends the Government Notification, Home Department No. GG/31/TTC/102010/282/V, dated the 25th June, 2010, as follows, namely:-

No.GG/36/PST/102014/20/V.- WHEREAS, the Government of Gujarat in exercise of the Procedure, 1973 (2 of 1974) in its application to the State Gujarat under Government Notification, Home Department No. G Procedure, 1973 (2 of 1974) in its application to the State Gujarat under Government GG/9/ETC/ 10 (2002)/ 1317 V, dated the 22nd January, 2007 had declared the posts and places specified in the Schedule to be the police stations of Vadodara (rural) District:

AND WHEREAS, the Government of Gujarat in exercise of the powers conferred by section 7 of the Gujarat Land Revenue Code, 1879 (Bom. V of 1879) under Government Notification, Revenue Department No. GHM/2013/72/PER/102013/139/LI, dated the 13th August, 2013 divided the Vadodara District into two districts, namely :-

1. Vadodara Districts; and
2. Chhotaudepur District.

Consisting of the talukas as specified in the said notification:

NOW THEREFORE, in exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat and in supersession of all the notifications issued in this behalf so far as they relate to the declaration of police stations of Vadodara (rural) district, the Government of Gujarat hereby:-

- (i) declares each of the posts and places specified in column (4) of the Schedule I and Schedule II appended hereto to be the police stations in the Talukas specified in column (3) thereof of the Vadodara (rural) district and Chhotaudepur District, respectively; and
- (ii) directs that each of such police stations shall include such police chowkey(s) or outposts; and local areas and villages as are respectively specified against each of the said police stations in column (5) or (6) and (7) of the said Schedules, as follows, namely:-
