No.GG/37/TTC/10(2002)/1318/V:- In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat hereby amends the Government Notification, Home Department No.GG/62/TTC/10-2002/1318/V, dated the 2nd July, 2005, as under :-

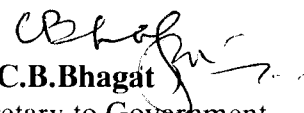
