No. GG-40-TTC-102005-623-/V:- In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat, hereby amends,-

NO.GG/45/2016/FSL/102008/1944/A:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Senior Expert, Class III, in the subordinate service under the Directorate of Forensic Science, Gujarat State, namely:-

1. These rules may be called the Senior Expert, Class III, in the Directorate of Forensic Science, Recruitment Rules, 2016.
2. Appointment to the post of Senior Expert, Class III, in the subordinate service of the Directorate of Forensic Science, Gujarat State, shall be made either, -
 - (a) by promotion of a person of proved merit and efficiency from amongst the persons, who, -
 - i. have worked for not less than five years in the cadre of Junior Expert, Class III, in the subordinate service of the Directorate of Forensic Science, Gujarat State, and
 - ii. have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:
