**No. GG-44-TTC-102005-623-/V:-** In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat, hereby amends,-

(1) the Government Notification, Home Department No.GG/85/TTC/10(2002)/1311/V, dated the 17<sup>th</sup> August, 2006 relating to Porbandar District as under,-
