

HOME DEPARTMENT**Notification**Sachivalaya, Gandhinagar 19th June, 2014.**Code of Criminal Procedure 1973.**

No. GG/46/TTC/10(2002)/1310/V:- In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat hereby amends the Government Notification, Home Department, No.GG/94/TTC/10(2002)/1310/V, dated the 11th November, 2005, as under :-

In the said notification, in the Schedule,

- (i) for the existing entry at serial No.6, the following entries shall be substituted, namely:-

- (ii) In the entry at serial No.9 relating to "Petlad" under the heading "Division/Sub-Division" specified in column (2), in the entry relating to "Mahelav" under the heading "Police Station" specified in column (4), the following entry under the heading "Villages" specified in column (7),) shall be deleted namely :-

"18. Petli";

- (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.

Provided that where the appointing authority is satisfied that a person having experience specified in sub-clause (i) above is not available for promotion and it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above, or

- (b) by direct selection.

3. The appointment by direct selection and by promotion shall be made in the ratio of 1:3 respectively.

4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall, -

- (a) not be more than 30 years of age :

provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967, and

- (b) possess -

(i) a degree obtained any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such by the Government or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised as such by the Government;

(ii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and

(iii) adequate knowledge of Gujarati or Hindi or both.

5. A candidate appointed by direct selection shall be on probation for a period of one year.

6. A candidate appointed by direct selection shall, during his probation period, require to undergo pre-service training and pass the post training examination in accordance with the rules prescribed by the Government.

7. A candidate appointed, by direct selection shall during his probation period, require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.

8. A candidate appointed by direct selection shall require to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.

9. A candidate appointed either by promotion or by direct selection shall require to under go such training and pass such examination as may be prescribed by the Government.

10. A candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as prescribed by the Government.
