### NOTIFICATION

## Sachivalaya, Gandhinagar, 23<sup>rd</sup> January 2014.

### Code of Criminal Procedure, 1973.

No.GG/18/PST/102013/667/V:- WHEREAS, the Government of Gujarat in exercise of the powers conferred by section & of the Gujarat Land Revenue Code, 1879 (Bom.V of 1879) under Government Notification, Revenue Department No.GHM/2013/71/ M/PFR/ 102013/139/L.1 dated the 13<sup>th</sup> August, 2013 divided,-

(1) the Ahmedabad District by excluding the following talukas so as to include the said talukas into newly formed Botad District, namely:-

1. Barvala;

2. Ranpur;

(2) the Bhavnagar District by excluding following talukas so as to include the said taluksa into newly formed Morbi District;

1. Botad;

2. Gadhada.

NOW, THEREFORE, in exercise of the powers conferred by clause(s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat hereby,-

(1) amends the Government Notification, Home Department No.GG/87/PST/102010/848/V, dated the 15<sup>th</sup> December, 2010 relating to the Ahmedabad District, so as to delete the police stations, posts and places alongwith the local areas and villages falling under Barvala and Ranpur talukas specified against the entries at serial Nos.12 and 13 under "Dholka Sub-Division" of the said notification;

(2) amends the Government Notification, Home Department No.GG/17/PST/ 102011/ 1155/V, dated the 17<sup>th</sup> March, 2012 relating to the Bhavnagar District, so as to delete the police stations, posts and places alongwith the local areas and villages falling under Botad and Gadhada talukas specified against the entry "4. Botad Sub-Division" of the said notification;

(3) declares the posts and places in column (4) of the Schedule appended hereto, to be the police stations in the talukas specified in column (3) thereof of the Botad District; and directs that each of such police stations shall include such police chokey(s) or outpost(s); and local areas and villages as are respectively specified against each of the said police stations in column (5) of (6) and (7) of the said Schedule, as follows, namely:-
