No. GG/65/TTC/10(2003)/1307(Part-1)/V:- In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat, hereby amends, the Government Notification, Home Department No.GG/80/TTC-10(2003)/1307/V, dated the 18th August, 2006 as under:-

In the said notification, in the Schedule, in the entry relating to “Ahwa” specified in column (2) under the heading “Division/Sub-Division”,-

(i) in the entry relating to “Ahwa” specified in column (4) under the heading “Police Station”, the entry relating to village “Chikhali(Lavchali)” as specified in column (7) under the heading “Local Areas/Villages” falling under it, shall be deleted;

(ii) in the entry relating to “Waghai” specified in column (4) under the heading “Police Station”, the entries relating to following villages as specified in column (7), under the heading “Local Areas/Villages” falling under it, shall be deleted, namely:-

“232. Khokhari,
233. Bardipada(Sajupada),
234. Sajupada,
238. Bandhpada and
239. Dhulda”;

(iii) in the entry relating to “Subir” specified in column (4) under the heading “Police Station”, the entries relating to following villages shall be added at the end, as specified in column (7), under the heading “Local Areas/Villages”, namely:-

“Chikhali(Lavchali),
Khokhari,
Bardipada(Sajupada),
Sajupada,
Bandhpada and
Dhulda”.
