CONSTITUTION OF IND)A

No. GS-2003-(10)CVO-122005-1077-Inq.Cell :-- In exercise of the powers conferred by the provise to article 309 of the Constitution of India, the Governor of Gujarat here by makes the following rules former to amend the Gujarat Civil Services (Descipline and Appeal) Rules, 1971, namely :-

- These Rules may be called the Gujarat Civil Services (Discipline and Appeal) (Amendment) Rules, 2003.
- (2) They shall come into force on the date o `their publication in the Official Gazette.

2. In the Gujarat Civil Services (Discipline and Appeal) Rules, 1971 in rule 5.

(a) In sub-rule (2Λ)

- (i) For the words "the date of order of suspension", the words "the effective date of suspension". Shall be substituted.
- (ii) the words "Notwithstanding anything contained in this rule" shall be deleted.
- (iii) at the end, the following proviso shall be added namely :-

"Provided that no such review of suspension shall be necessary in the case of deemed suspension inder sub-rule (2), if the Government servant continues to be under suspension at the time completion of ninety days suspension and the ninety days period in such case will count from the date the Government servant detained in custody is released from detention or the date on which the fact of his release from detention is intimated to his appointing authority, whichever is later."

(b) In sub-rule (5), for clause (a), the following clause shall be substituted, namely :-

"(a) Subject to the provisions contained in sub-rule (2A), an order of suspension made or deemed to have been made under this rule shall continue to remain in force until it is modified or revoked by the authority competent to do so."
