No.GG/15/PST/102013/783/V:- WHEREAS the Government of Gujarat in exercise of the powers conferred by section & of the Gujarat Land Revenue Code, 1879 (Bom.V of 1879) under Government Notification, Revenue Department No.GHM/2013/74/M/PFR/102013/139/L. 1 dated the 13th August, 2013 divided,-(1) The Rajkot District by excluding the following talukas so as to include the said talukas into newly formed Morbi District, namely:-

1. Morbi
2. Maliya
3. Vankaner
4. Tankara

- (1) The Surendranagar district by excluding Halvad taluka so as to include the said taluka into newly formed Morbi District;
- (2) The Jamnagar district by excluding 14 villages of Jodiya Taluka so as to include the said villages into newly formed Morbi District;

NOW, THEREFORE, in exercise of the powers conferred by clause(s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat hereby,-

- (1) Amends the Government Notification, Home Department No.GG/83/TTC/10(2002)/1314/V, dated the 17th August, 2006 relating to the Rajkot District, so as to delete the entries at serial numbers 8 to 14 relating to Morbi, Maliya, Vankaner and Tankara talukas, respectively and the police stations thereunder alongwith the local areas and villages;
- (2) Amends the Government of Bombay, Home Department Notification No. GG/40/TTC/ 102010/ 280/V, dated the 13th July, 2010 relating to the Surendranagar District, so as to delete the entry relating to Halvad taluka and the police stations thereunder alongwith the local areas and villages;
- (3) Declares the posts and places in column (4) of the Schedule appended hereto, to be the police stations in the talukas specified in column (3) thereof of the Morbi District and. directs that each of such police stations shall include such police chokey(s) or outpost(s); and local areas and villages as are respectively specified against each of the said police stations in column (5) of (6) and (7) of the said Schedule, as follows, namely:-

CONSTITUTION OF INDIA.

No.GHS-2013/ 24 /CLE-102013-467114-M(1) :-In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Librarian, Class III, in the subordinate service of the Commissionerate of Labour, namely:-

1. These rules may be called the Librarian, Class III, Recruitment Rules, 2014.
2. Appointment to the post of Librarian, Class III, in the subordinate service of the Commissionerate of Labour shall be made either,
 - (a) by direct selection, or
 - (3) by temporary transfer on deputation basis from amongst the persons working on the cadre of District Librarian/Professional Assistant, Class III, in the subordinate service of the Directorate of Libraries.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-
 - (a) not be more than 33 years of age;
Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
 - (b) possess,-
 - (i) a degree obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or declared as deemed to be a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised by the Government;
 - (ii) a degree in the Library and Information Science obtained from any of the Universities established or incorporated, by or under the Central or State Act in India; or any other educational institution recognised as such or declared as deemed to be a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised by the Government;
 - (iii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
 - (iv) adequate knowledge of Gujarati or Hindi or both;
 - (c)
 - (i) have about two years experience on the post not below the rank of Library Clerk, Class III, in the Government Service; of
 - (ii) have about two years experience of inspection and/or administration of Libraries in Government undertaking board or corporation or in local bodies or in University or College on the post which can be considered equivalent to the post not below the rank of Library Clerk, Class III, in the Government service; or
 - (iii) have about two years experience of inspection and/or administration of Libraries of registered trust or public sector or private sector organization on the post which can be considered equivalent to the post not below the rank of Library Clerk, Class III, in the Government service.
4. The candidate appointed by direct selection shall be on probation for a period of one year.
5. The candidate appointed by direct selection shall, during his probation period, require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
