No. GG/31/2023/DYS/102021/1647/B :- In exercise of the powers conferred by clause (b) of section 5 of the Gujarat Police Act, 1951 (Guj..XXII of 1951), the Government of Gujarat hereby makes the following rules further to amend the Police Inspector (Unarmed), Class II, Recruitment Rules, 2017 namely :-

1. These rules may be called the Police Inspector (Unarmed), Class II, Recruitment (Amendment) Rules, 2023.
2. In the Police Inspector (Unarmed), Class II, Recruitment Rules, 2017, in rule 2,-
 - (i) in clause (a), in sub-clause (vi), after the word "Training of Police Organisation", the words "or Anti-Terrorist Squad or Coastal Security or Gujarat State Human Rights Commission or PC & PNDT Cell under the Health and Family Welfare Department or State Traffic Branch or Offices under the Gujarat Urja Vikas Nigam Limited or Application Branch or Local Intelligence Bureau (L.I.B.) or Special Branch or Modus Operandi Branch (M.O.B.) or Reader Branch or Control Room working in the Offices of Commissionerate of Police/ Superintendent of Police or Salamati Branch at the Gujarat Legislative Assembly or G.1, G.2 and Suraksha Setu Branches working under the Office of the Director General and Inspector General of Police" shall be inserted.
