CONSTITUTION OF INDIA.

No. GP/03/DLB-102010/2642/JH.— In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, and in superssesion of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Junior Scientific Officer, Class-I in the Gujarat food and drugs Services in the food and drugs laboratory (Drugs Wing) under the food and drugs control administration in the Commissionerate of food and drugs control administration namely:

- These rules may be called the junior Scientific Officer, Class-I, in the food and drugs laboratory (drugs wing) under the food and drugs control administration in the Commissionerate of food and drugs control administration, Recruitment Rules, 2012.
- Appointment to the post of junior Scientific Officer, Class-1 in the Gujarat food and drugs services, in the food and drugs laboratory (drugs wing) under the food and drugs control administration in the Commissionerate of food and drugs control administration shall be made either,-
 - (a) -by promotion of a person of proved merit and efficiency from amongst the persons, who-
 - (i) have worked for not less than eight years in the cadre of Senior Scientific Assistant, Class-II, in the Gujarat food and drugs services, in the food and drugs laboratory (drugs wing] under the food and drugs control administration in the Commissionerate of food and drugs control administration;
 - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006;

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period, it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified in sub-clause (i) above.

Or

- (b) by direct selection.
- 3. The appointment by direct selection and by promotion shall be in the ratio of 1:3 respectively.

- 4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall-,
 - (a) not be more than 35 years of age.

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the services of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General)Rules, 1967.

- (b) Possess,
 - (i) a post graduate degree with at least 50 percentage in Pharmacy or Pharmaceutical Chemistry or in Medicine with specialization in Clinical Pharmacology or Microbiology obtained from an University established or incorporated by or under the Central or State Act in India; or any other educational institute recognized as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognized as such by the State Government.
 - (ii) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.
- (c) (i) have not less than five years experience on the post not below the rank of Junior Scientific Assistant, Class III, in the subordinate service of the Commissionerate of the food and drugs control administration; or
 - (ii) have not less than five years experience of working as Enforcement Unit on the post not below the rank of Class III in the Government to implement the Drugs and Cosmetics Act, 1940 and rules made thereunder; or
 - (iii) have not less than five years experience in manufacturing or testing of drugs in the production department or quality control department or research and development in the fields related to Pharmaceutical Technology or in enforcement of the provisions of the Drugs and Cosmetics Act, 1940 and rules made thereunder; and;
- (d) Possess adequate knowledge of Gujarati or Hindi or both.
- 5. The candidate appointed by direct selection shall be on probation for a period of two years.
- 6. The candidate appointed by direct selection shall, during the probation period require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Civil Services Computer Competency Training and Examination Rules, 2006;
- 7. The candidate appointed by direct selection shall, during the probation period require to undergo preservice training and pass post training examination in accordance with the Gazetted Officer's (Pre-Service Training and Examination) Rules, 1970.
- 8. The candidate appointed by direct selection shall require to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
- 9. The candidate appointed either by promotion or by direct selection shall require to undergo such training and pass such examination as may be prescribed by the Government.
- 10. The selected candidate shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
