CODE OF CRIMINAL PROCEDURE, 1973.

CODE OF CRIMINAL PROCEDURE 1973.

No. GG/292/TTC/2180/5097/V.— In exercise of the powers conferred by clause (S) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat the Government of Gujarat hereby amends the Government of Bombay, Home Department Notification No. 7962/6, dated 30th October, 1954, as follows, viz.

In the said notification, under the heading "2. Kadi Taluka" of the Kadi Taluka for the entry "77. Naranpura (petapara)" the following entry shall be substituted namely :—

"77 Naranpura".
