CONSTITUTION OF INDIA.

NO.GP-S-RRS-102009-1630-CHH:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to post of Librarian, Class III in the subordinate service of the Directorate of Indian System of Medicine and Homeopathy, Gujarat state namely:-

1. These rules may be called the Librarian, Class III, Directorate of Indian System of Medicine and Homeopathy Recruitment Rules, 2016.
2. Appointment to the post of Librarian, Class III, in the subordinate service of the Directorate of Indian System of Medicine and Homeopathy, Gujarat state, shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall -

- (a) not be more than 36 year of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (b) possess

- (i) A degree obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed University under section 3 of the University Grants Commission Act, 1956, or possess an equivalent qualification recognised as such by the Government; and
- (ii) A degree in Library and Information Science obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any

other educational institution recognised as such or declared to be deemed University under section 3 of the University Grants Commission Act, 1956;

- (c) possess basic knowledge of computer application as prescribe in the Gujarat Civil Service Classification and Recruitment (General) Rules, 1967; and
 - (d) possess adequate knowledge of Gujarati or Hindi or both.
4. The provisions of rule 9 A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.
5. A candidate appointed by direct selection shall require to undergo such training and to pass examination as may be prescribed by the Government.
6. A candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.

PRISONS ACT, 1894.

No. GG-7/2016/JLM/502007/3122/J :- In exercise of the powers conferred by clause (10) of sub-section (1) of section 59 read with section 6 of the Prisons Act, 1894 (IX of 1894), the Government of Gujarat hereby makes the following rules further to amend the Subedar (Female), Class III, in Jail Department, Recruitment Rules, 2015, namely, :-

1. These rules may be called the Subedar (Female), Class III, in Jail Department Recruitment (Amendment) Rules, 2016.
2. In the Subedar (Female), Class III, in Jail Department Recruitment Rules, 2015, in rule 3. in clause(a), for the figures and word "35 years", the figures and word "40 years" shall be substituted.
