
No.GG/49/PST/102010/848/V:- In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat hereby amends the Government Notification, Home Department No.GG/87/PST/102010/848/V, dated the 15th December, 2010, as under, namely:-

In the said notification, in Schedule,

- (i) in the entry at serial no.1, in the entry relating to "Sarkhej Police Station" and local areas/villages respectively, specified in column 4 and 7 shall be deleted:
