Code of Criminal Procedure, 1973. **No. GG** /27/TTC/10(2002)/1317/Part-2/V:- In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat hereby amends the Government Notification, Home Department No. GG/95/TTC/10(2002)/1317/V, dated the 11<sup>th</sup> November, 2005, as under:-
