Resolution:-

Consequent upon discussions held during the Coastal Security review Meeting held on dt.06/06/2016 under the Chairmanship of Hon'ble Union Home Minister, it has been decided to constitute State/UT level Coastal Security Committees and District Level Coastal Security Committees in the Coastal States/UTs to monitor, manage and steer the various issues of the Coastal Security at these levels.

Considering the importance of coastal security and border security, State Level and Department Level Review Committees are constituted by the State Government vide Home Department GR dt:04-12-2014. In pursuance to the decision taken by the Government of India, State Government has decided to reconstitute the coastal security committees all ready in existence. In accordance to the decision taken by the Government of India, State Government has also decided to constitute District Level Coastal Security Committee.

The formation and terms of reference of these committees are as under :

State Level Coastal Security Committee:

(b) Terms of Reference:

- The State Level Coastal Security Committee will monitor the relevant aspects of the Coastal Security as are being coordinated/taking care of at Coastal State Level.
- The Committee will review functioning & monitoring of District level Coastal Security Committees.
- The Chairman of the Committee will incorporate appropriate members as special invitees for specific issues, if needed.
- The Committee will meet every six months.
